RICO Prosecution of Election Fraud Conspirators

RICO Election Fraud Conspiracy

The Governors and Secretaries of State ("conspirators") of MI, WI, PA, NV, GA, and AZ ("conspirator states") are engaged in a racketeering enterprise to fraudulently overturn Donald Trump's election victory in those states. Overwhelming and incontrovertible evidence proves they conducted a pattern of racketeering activity in violating two or more federal and state laws in planning and coordinating electoral fraud. They conspired with hundreds of poll workers, Dominion Voting Systems, Democrat politicians and operatives, foreign actors including China, people in federal and state governments, and many other individuals and businesses.

The DOJ and FBI could rapidly acquire evidence of massive fraud if they tried. By not trying, the DOJ and FBI are aiding and abetting the conspirators and complicit in the election fraud coup.

AG Barr reports to President Trump. President Trump and Rudy Giuliani should meet with AG Barr to present the evidence. President Trump would tell AG Barr that Barr is going to abide by his oath of office to protect and defend the constitution by personally leading a DOJ/FBI RICO investigation into the election fraud conspiracy.

The first investigation phase will be to immediately impanel grand juries, obtain surveillance warrants on the conspirators, and subpoena ballot information for Jovan Hutton Pulitzer and his team to identify fraudulent ballots.

Plan

President Trump meets with AG Barr

- 1. President Trump's attorneys prepare a document in the form of a criminal complaint for RICO Act crimes committed by the conspirators. The document contains evidence of the conspirators' violations of federal and state law that demonstrate their pattern of racketeering activity.
 - a. Same modus operandi: coordinated suspension of vote counting followed by extraordinarily large and statistically impossible vote batches putting Biden ahead, fraudulent ballots, not correcting counts for proven illegal votes, destruction of evidence.
 - b. Millions of China made ballots used.
 - c. Dominion software algorithm switching Trump votes to Biden
 - d. Statistically impossible votes (e.g., 94,800 Biden only and 800 Trump only ballots in Georgia).
 - e. Hundreds of witness affidavits attesting to election fraud
 - f. Foreign election interference
- 2. AG Barr reports to President Trump. President Trump and Rudy Giuliani meet with AG Barr to present the evidence. President Trump would tell AG Barr that he is going to abide by his oath of office to protect and defend the constitution by personally leading a DOJ/FBI RICO investigation into the election fraud conspiracy. Christopher Wray will not be involved and will receive no information on the investigation.

Implement the DOJ/FBI RICO criminal investigation Plan

Phase 1 - Rapidly Identify Fraudulent Ballots

Assign the most trusted DOJ officials (such as Jeffrey A. Rosen) to manage the
investigation in each state. Bring in additional trusted US attorneys, such as
Jeff Jensen of Missouri, and FBI agents to supplement resources at the DOJ and
FBI offices in the conspirator states.

- Based on the evidence, immediately impanel grand juries in neutral jurisdictions in each state (not cities with rampant election fraud such as Philadelphia, Atlanta, Detroit).
 - Have eyewitnesses and expert witnesses testify, and present evidence in Rudy Giuliani's document.
- Immediately obtain warrants to surveille communications of the conspirators,
 Dominion employees, Staple Street Capital principals and employees, the UK citizen Mark Malloch-Brown (Chair of Smartmatic's parent company), etc.
- Obtain a court order for all states to retain voting records, electronic and hard copy) and voting equipment. Communicate to all states that anyone who violates the order will be prosecuted for destruction of evidence.
 - After a forensic audit of Antrim County's Dominion voting machines found an error rate of 68.5%, the Michigan Secretary of State ordered deletion of e-poll books and other evidence.
- Obtain a court order to obtain custody in all states of the physical ballot, the image scan of the ballot in the machine, digital images of ballots scanned (e.g., in Georgia recount), the CVR file in the machine.
 - Provide this ballot information to Jovan Hutton Pulitzer to identify fraudulent ballots. (Ref to video link: https://youtu.be/UgeqGmvQXKs)
- Obtain a court order to prevent the conspirators and Dominion employees from leaving the country.

Phase 2 - Investigate Conspiracy, Dominion fraud, and foreign interference

- Obtain a court order to do a forensic examination of the voting equipment, software, and accessories (USB's) in the conspirator states.
 - Immediately verify Georgia Ware County 's Dominion machine's vote switching algorithm.
 - Immediately verify Michigan Antrim County 's Dominion machine's vote switching algorithm.
- Interview all witnesses who signed affidavits for the Trump attorney lawsuits, and trace who was involved in the vote counting suspension, and the extraordinarily large ballot batches after the suspension was lifted.
 - o Interview poll workers implicated in the election fraud
 - o Interview Poll workers contracted for Detroit
 - Interview Poll workers on camera in Atlanta pulling suitcases of ballots from under a table after they told observers to go home.
 - Investigate deliveries of large quantities of ballots after vote counting was suspended.
 - Investigate the extremely large batches of votes recorded after the vote counting suspension was lifted.

- Investigate to find out who coordinated the vote counting suspension and subsequent large batches of votes recorded.
- Investigate Foreign Interference
 - Investigate the \$400 million equity investment that UBS securities made in Dominion's parent company - the private equity firm Staple Street Capital.
 - Investigate ballots made in China
 - Investigate contributions of value (e.g., money, property, etc.,) given to the conspirators and their families.

Invoke the Insurrection Act

Jovan Hutton Pulitzer said his team can identify fraudulent ballots in one day after receiving the ballots, so this investigation will uncover massive election fraud extremely rapidly.

The AG Barr, John Ratcliffe, and President trump will make following announcements together:

AG Barr will announce the massive election fraud, including the number of fraudulent ballots, found in the DOJ/FBI RICO criminal investigation of domestic and foreign conspirators. Barr will explain the RICO investigation and the criminal penalties. He will encourage people with knowledge of crimes to call a whistleblower phone number.

The Director of National Intelligence John Ratcliffe will announce the results of his assessment of any foreign interference in the election and any methods employed to execute it, the persons involved, and the foreign government or governments that authorized, directed, sponsored, or supported it.

President Trump will explain that domestic and foreign conspirators attempted to overthrow the government of a duly elected president. President Trump will announce that he is invoking the Insurrection Act because the foreign and domestic leaders of the coup are still unknown, and their next actions may be perilous to the nation. For this reason, the following steps are effective immediately:

- Martial law declared
- Habeas Corpus suspended
- Military tribunals will prosecute conspirators
- Military and national guard deployed to perform investigations and maintain order.
- People participating in violence prosecuted or treason

The joint announcement of the DOJ/FBI RICO criminal investigation's discovery of massive fraud and the DNI's assessment of foreign interference are essential to the Americans' support of President Trump's actions. The invocation of the Insurrection Act and Declaration of martial law is extremely important due to the politicization of our judiciary, legislature, and executive branches and the infiltration of Chinese influence in these institutions. This politization is the very reason why this largescale election fraud was successful, and the reason why the perpetrators, including high-level politicians and billionaires, are confident they will never be brought to justice. They have powerful attorneys and friends in high places to protect them. The system is rigged in their favor with corrupt politicians like Nancy Pelosi and Joe Biden, corrupt judges like Emmet Sullivan, and corrupt prosecutors like Jesse Liu. Martial law, military investigations in conjunction with the DOJ/FBI, military tribunals, and military prisons are the only way to bring them to justice and prevent such a terrible event from occurring again. This will also open the eyes of all Americans to the truth of corrupt government employees and our greatest national security threat - the Chinese Communist Party.
